Power plants can generate electricity from a number of different fuel sources, resulting in different emissions. Constellation will report fuel sources and emissions data to customers twice annually, allowing customers to compare data among the companies providing electricity service in Maryland.

Air Emissions

The amount of air pollution associated with the generation of the electricity production for this region is shown in the table at right.

Sulfur Dioxide (SO ₂)	0.33
Nitrogen Oxides (NO _x)	0.27
Carbon Dioxide (CO ₂)	753.93

CO₂ is a “greenhouse gas,” which may contribute to global climate change. SO₂ and NO_x released into the atmosphere react to form acid rain. NO_x also react to form ground level ozone, an unhealthful component of “smog.”
